This innovative micro-credential equips financial professionals with essential **Environmental, Social, and Governance (ESG) skills**, increasingly demanded across the sector.

Structured as a robust **2 ECTS qualification**, the programme features two core units that introduce ESG principles and practices tailored to the financial industry. To further support career progression and specialization, the development team has designed four additional units focusing on ESG applications in credit, insurance, investment and risk management. These optional units could be fully developed by providers and allow learners to "stack" their learning, paving the way toward a broader, more comprehensive ESG certification.

The micro-credential is **accredited by University College Dublin (UCD)**, with IOB operating as a recognized college, thereby ensuring adherence to the **highest academic and quality standards**. As a result, the programme is now formally integrated into the university's award framework—combining practical relevance with academic excellence.

Ireland's leadership in this initiative is mirrored by **Malta**, where a national pilot of the ESG-focused micro-credential is underway. The programme is in its final stages of approval, with its launch expected later this year.

This growing momentum across Europe highlights the region's shared commitment to **embedding ESG competencies into financial services training**, setting the foundation for broader cross-border recognition of micro-credentials within the EU.
