Successful Launch of the pilot MiCreS Micro-Credential in ESG for Financial Services in Ireland and Malta

The MiCreS Micro-Credential in ESG for Financial Services has successfully launched, and the pilot is now officially underway in both Ireland and Malta. This milestone marks a significant step forward in strengthening financial sector capabilities across Europe as organizations accelerate their transition toward more sustainable, resilient, and responsible economic practices.

The Micro-Credential has been designed to equip learners with practical, future-focused skills that address the rapidly evolving landscape of sustainable finance.

Strong Engagement Across Both Countries

The programme has already attracted a diverse cohort of participants, including 40+ participants from banking, public authorities, funds and payment companies.


